Eligibility criteria and other terms and conditions are as follows:

- Functions, Powers and responsibilities of the Forum and its Member are specified in "Bihar Electricity Regulatory Commission (Consumer Grievance Redressal Forum, Electricity Ombudsman and Consumer Advocacy) Regulations, 2017 & subsequent amendment which can be seen on the website of the Commission www.bere.co.in.
- 2. (a) The Chairperson should be a retired Judicial Officer not below the rank of Additional District and Session Judge or a retired officer of Bihar Administrative Service not below the rank of District Magistrate/Additional Collector or retired superintending engineer of licensee or equivalent post with minimum 20 years experience. Preference shall be given to the officer having experience of Judicial/ Quasi Judicial work and has shown capacity in dealing with problems relating to Electricity Regulatory matters and familiar with the consumers affairs service.
  - (b) Chairperson and Third Member of the forum shall hold office for a fixed term of three years, from the date of appointment or till he/she attains the age of 65 years whichever is earlier. The tenure of a member may be extended by the licensee for a further period of two years or till he/she attains the age of 65 years whichever is earlier with prior approval of the Commission.
- 3. The Third Member shall be Independent Member. The person shall be a representative of a registered society/NGO/ consumer organisation having one of its main objectives as consumer protection with at least 5 (five) years of standing or alternatively the representing member should have five years of experience in consumer-related matters or a person of stature and repute having at least five years exposure and experience of consumer affair and the minimum qualification shall be graduate in any discipline from a recognized university.

Provided that, a person applying for the post of Independent Member of the Forumshall not have been in the employment in any capacity under, or agency of, the Distribution Licensee for a minimum period of three (3) years prior to being appointed Independent Member of the Forum.

- 4. The maximum age for appointment to the post of Chairperson and third Member shall be 62 years as on the last date of receipt of the application. The minimum age for third Member shall be 35 years on the last date of receipt of the application.
- The candidate should be an experienced person of ability, integrity and standing having adequate knowledge in his respective fields. He shall devote his whole time for the Forum's work and not undertake any other part time or honorary work.
- 6. No person shall be appointed and/ or be entitled to continue as a chairperson or third member if he/she stands disqualified on account of his/her;
  - a) Having been adjudged an insolvent;
  - b) Having been convicted of an offence which, in the opinion of the licensee, involves moral turpitude;
  - c) Having become physically or mentally incapable of acting as such a member,
  - d) Having acquired such financial or other interest as is likely to affect prejudicially his/her functions as a member;
  - e) Having so abused his/her position as to render his/her continuance in office prejudicial to public interest; or
  - f) Having been guilty of proved misbehavior.
  - g) Having become Member of any Political Party.
- 7. The Chairperson and Third Member may relinquish his/her office by giving prior notice in writing not less than three months to the appointing authority. Similarly, if the Chairperson of the Forum is removed by the licensee, Licensee shall give prior notice in writing not less than three months to the Chairperson of the Forum.
- (a) The sitting fees, honorarium and/ or other allowances (Collectively "Remunerations")
  payable to the Chairperson shall be decided by the licensee with the approval of the
  Commission.
  - (b) The Third Member (Independent Member) shall be entitled for per sitting remuneration of Rs. 2500/- (Rupees Two thousand five hundred) only including TA for each day of participation in the Forum's proceedings and work.
- The candidate who fulfils the above criteria and is desirous of appointment on the said post, must submit application addressed to the Secretary, Bihar Electricity Regulatory Commission, Vidyut Bhawan-II, J.L.
